Rules:

- Sheridan Days Art Show defines a professional artist as one who, regardless of age, receives income from their art.
- Professional entries are not eligible for judging.
- Heritage entries are not judged.
- Applications must be submitted on or before June 10th, 2012.
- Artwork will not be accepted w/out completed entry form and payment.
- All entries must be ready to hang or display.
- Photographs must be mounted on sturdy backing-ready to hang.
- Entries to be judged must be the work of the exhibitor.
- No artwork will be released before 3:15 pm Sunday, June 17th.
- Limit 3 entries per person per category.
